OPERATING MILLAGE PROPOSAL

For the purpose of supporting the continued operation at the Jackson District Library, shall the limitation upon taxes that may be assessed within the library service area in one (1) year be authorized at 0.40 mills (\$0.40 on each \$1,000 of taxable value on all real and tangible personal property) for a period of 9 years beginning 2008 through 2016, inclusive, to provide funds for operating purposes?

The Jackson District Library is composed of 13 branches throughout Jackson County.
