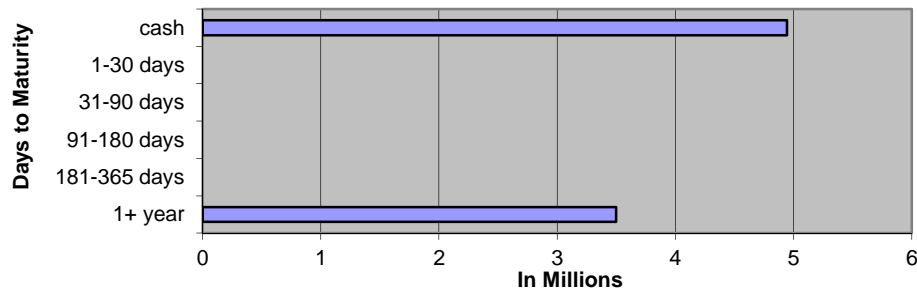

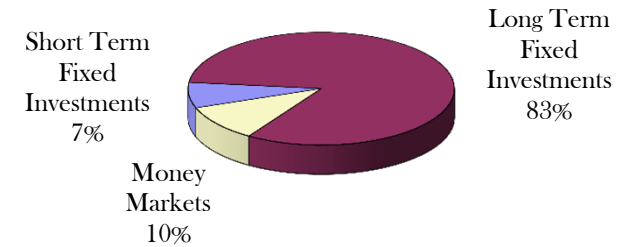

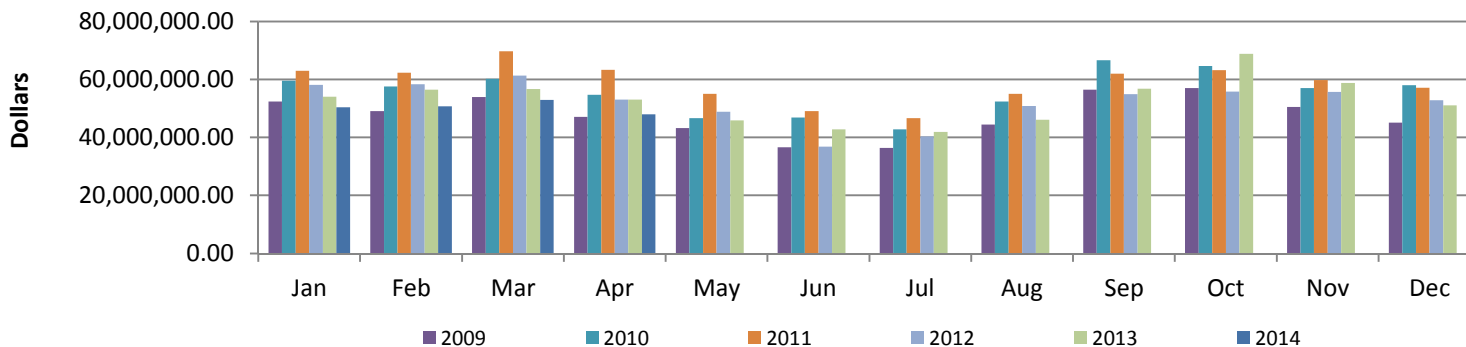
Diversification by Maturity Date

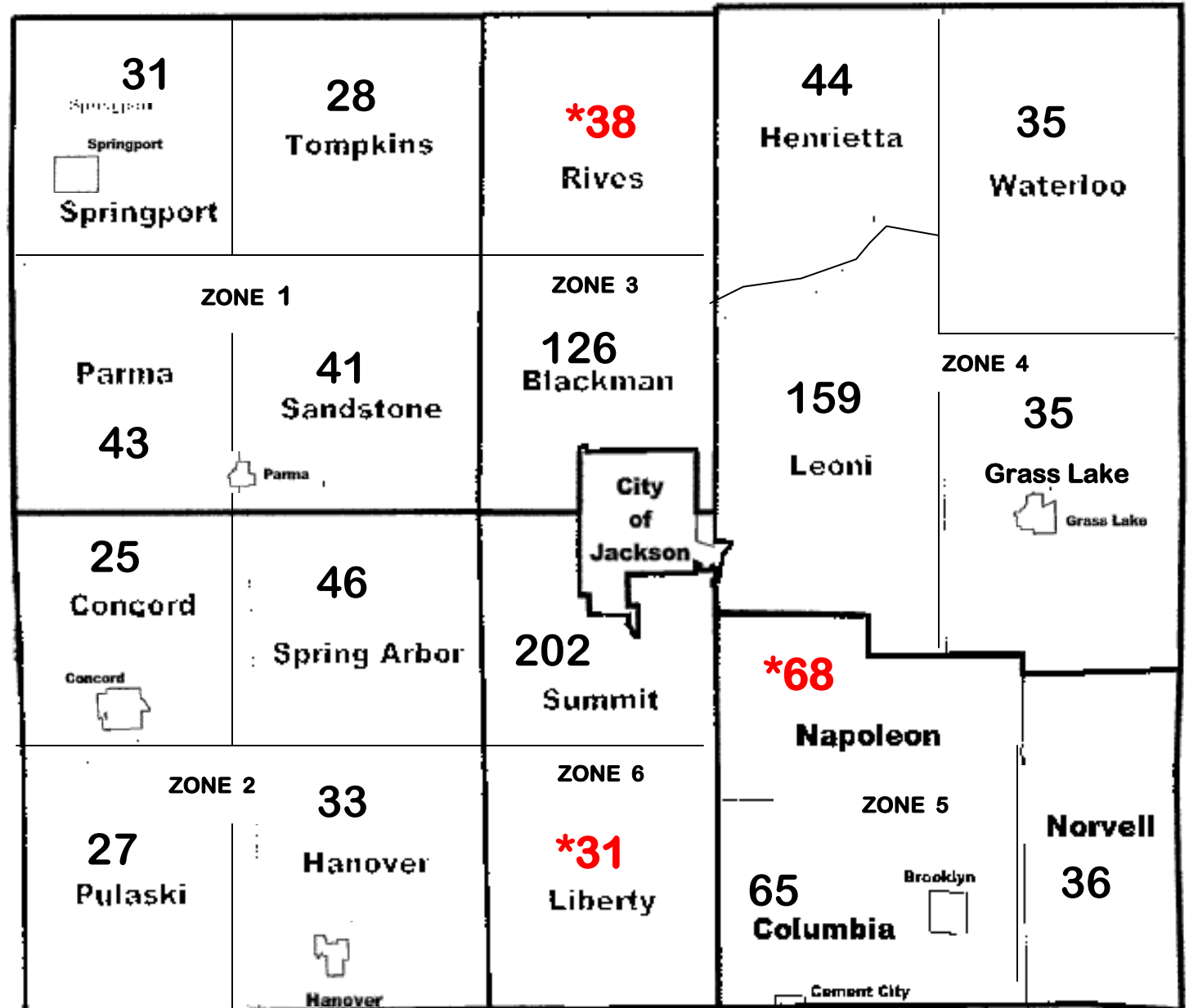
