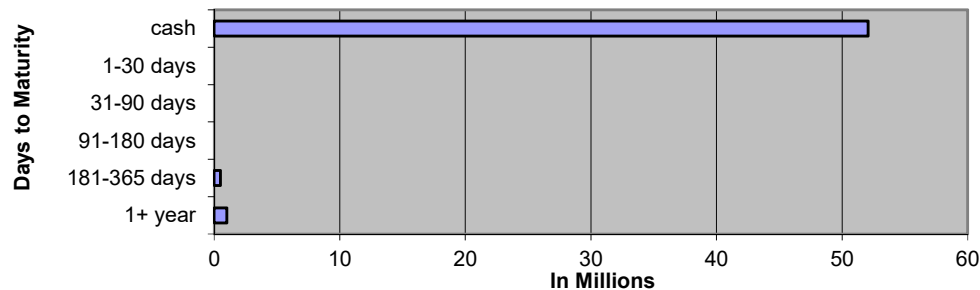

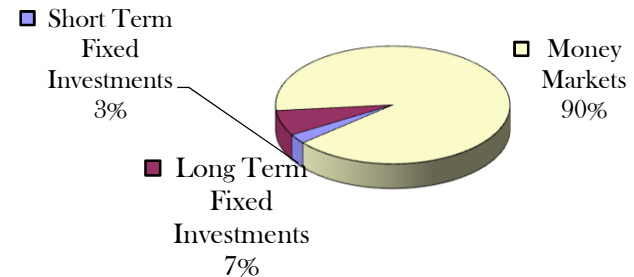

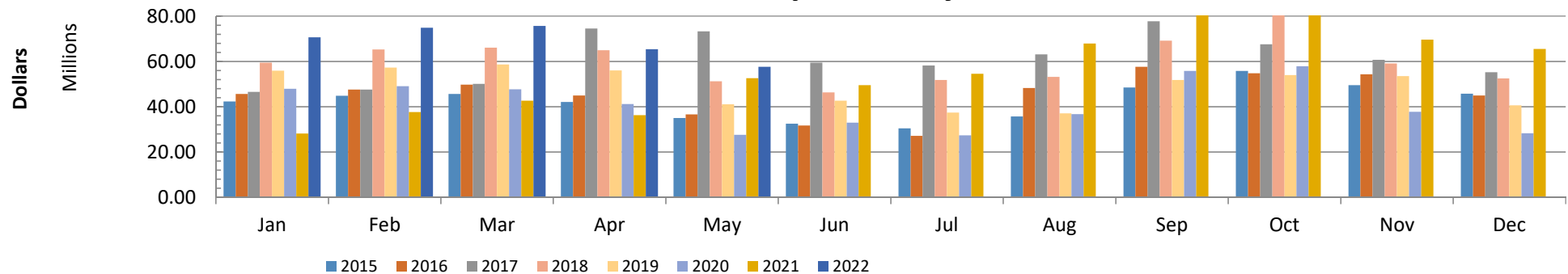
Diversification by Maturity Date
