Monday, September 27, 1993 in Springport Public Schools, Jackson County, Michigan (the "District"), and canvassed by the Board of County Canvassers of Jackson County, Michigan.

STATEMENT OF VOTES

The statements of votes polled in the one (1) voting precinct of the District, (and in the Absent voter's County Board) of the Springport Public Schools at the Special Election held on Monday, September 27, 1993, has been filed with the Jackson County Clerk, and with this Board. Having examined and considered said statement, this Board has canvassed the votes cast for and against the proposition, reading:

BONDING PROPOSITION

Shall Springport Public Schools, Jackson, Calhoun, Eaton and Ingham Counties, Michigan, borrow the sum of not to exceed Four Million Nine Hundred Seventy-Five Thousand Dollars (\$4,975,000) and issue its general obligation unlimited tax bonds therefor, for the purpose of erecting, furnishing and equipping a classroom addition to the Annex and remodeling and re-equipping the Annex for elementary school purposes; erecting, furnishing and equipping a gymnasium addition to the high school building; and developing and improving sites?


3. All school electors who were registered with the city or township clerk of the city or township in which they reside were permitted to vote at the special election held on Monday, September 27, 1993.
