STATEMENT OF VOTES

The statement of votes cast in the one voting precinct [and in the Absent Voter's Counting Board] of the VANDERCOOK LAKE PUBLIC SCHOOLS at the Special Election held on Thursday, September 30, 1993, has been filed with the Jackson County Clerk and with this Board. Having examined and considered said statement, this Board has canvassed the votes cast for and against the proposition, reading:

A. MILLAGE RENEWAL PROPOSITION FOR OPERATION

Shall the limitation on the amount of taxes which may be assessed against all property in Vandercook Lake Public Schools, Jackson County, Michigan, be increased by 7.00 mills (\$7.00 on each \$1,000) on state equalized valuation for the year 1993, for the purpose of providing additional funds for operating purposes (this being a renewal of 7.00 mills for operating purposes which expired with the 1992 tax levy)? (The revenue increase in 1993 to be realized from the 7.00 mills, if approved and levied, will be approximately \$306,122.)

The statement of votes cast in the one voting precinct [and in the Absent Voter's Counting Board] of the VANDERCOOK LAKE PUBLIC SCHOOLS at the Special Election held on Thursday, September 30, 1993, has been filed with the Jackson County Clerk and with this Board. Having examined and considered said statement, this Board has canvassed the votes cast for and against the proposition, reading:

B. MILLAGE PROPOSITION FOR OPERATION

Shall the limitation on the amount of taxes which may be assessed against all property in Vandercook Lake Public Schools, Jackson County, Michigan, be increased by 2.26 mills (\$2.26 on each \$1,000) on state equalized valuation for the year 1993, for the purpose of providing additional operating funds? (The revenue increase in 1993 to be realized from the 2.26 mills, if approved and levied, will be approximately \$98,834.)


