NON-HOMESTEAD AND NON-QUALIFIED
AGRICULTURAL PROPERTY TAX

This millage will allow the school district to continue to levy not more than the statutory rate of 18 mills against non-homestead and non-qualified agricultural

property required for the school district to receive its revenue per pupil foundation guarantee and renews millage that will expire with the 1997 tax levy.

Shall the currently authorized millage rate limitation for operating purposes on the amount of taxes which may be assessed against all non-homestead and non-qualified agricultural property, as defined by law, in East Jackson Community Schools, Jackson County, Michigan, be renewed by 18 mills (\$18.00 on each \$1,000 of taxable valuation) for a period of 15 years, 1998 to 2012, inclusive; the estimate of the revenue the school district will collect if the millage is approved and levied in the 1998 calendar year is approximately \$961,000 (this being a renewal of millage which will expire with the 1997 tax levy)?
