STATEMENT OF VOTES CAST

The statement of votes cast in the one voting precinct of the VILLAGE OF SPRINGPORT at the Special Election held on Tuesday, April 10, 2001 has been filed with the Jackson County Clerk and with this Board. Having duly examined and considered said statement, this Board has canvassed the votes cast for the special bond proposal as follows:

Unlimited Tax Pledge to Support Sanitary Wastewater Bond

Shall the Village of Springport, County of Jackson, Michigan (the Village) make an unlimited tax pledge for the years 2001 to 2020, inclusive, to support the tax obligation of the Village on the Village's General Obligation Limited Tax Bond (the "Bonds"), issued on September 30, 1999 in the original principal amount of \$735,000 for sanitary wastewater purposes? The maximum principal amount of Bonds to be secured by the unlimited tax pledge is \$705,000.

The estimated millage to be levied in 2001 is 7.59 mills (\$7.59 per \$1,000 of taxable value) and the estimated simple average annual millage rate required to support the Bonds is 7.0 mills (\$7.00 per \$1,000 of taxable value).

THE UNLIMITED PLEDGE SHALL BE PAYABLE FROM THE GENERAL FUNDS OF THE VILLAGE INCLUDING AD VALOREM TAXES LEVIED WITHOUT LIMIT IN SUFFIECIENT AMOUNTS TO PAY THE ANNUAL PRINCIPAL OF AND INTEREST ON THE BONDS.
