STATEMENT OF VOTES

The statement of votes cast in the one voting precinct of the CONCORD COMMUNITY SCHOOL DISTRICT at the Special Election held on Tuesday, March 20, 2001 has been filed with the Jackson County Clerk and with this Board. Having duly examined and considered said statement, this Board has canvassed the votes given for and against the proposition reading as follows:

BONDING PROPOSAL

Shall Concord Community Schools, Jackson County, Michigan, borrow the sum of not to exceed Thirteen Million Seven Hundred Forty-Five Thousand Dollars (\$13,745,000) and issue its general obligation unlimited tax bonds therefor, for the purpose of:

erecting, furnishings and equipping an addition or additions to and/or remodeling, refurbishing and re-equipping the existing school buildings to include acquiring and installing educational technology; construction improvements to the outdoor athletic facilities; and developing and improving sites?

The following is for informational purposes only:

It is expected that the Bonds will be outstanding for not more than 30 years, exclusive of refunding. Under current law the proposed issue has an estimated millage rate for the year 2001 of 7 mills (\$7.00 for each \$1,000 of taxable valuation) and an estimated simple average annual millage rate of 6.84 mills (\$6.84 for each \$1,000 of taxable valuation).

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)




